## PUBLIC LAW 111-79

### Effect of Government Seal on Document

Pursuant to the United States of America Republic Constitution Amendment 19, Section 2, Clause 2, wherein it states; “*The United States of America Republic shall make all Laws which shall be necessary and proper for carrying into Execution the foregoing Powers, and all other Powers vested by this Constitution in the Government of the United States of America Republic, or any Department or Officer thereof*”, there shall hereby be designated “**Effect of Government Seal on Document**” provisions to serve this purpose. This amendment shall go into immediate force.

Introduced as **Senate Joint Resolution 111-79**, with 29 co-sponsors and as **House Joint Resolution 111-75** with 29 co-sponsors, a request was delivered before the Continental Congress to honor and therefore establish laws for our **Effect of Government Seal on Document**.

The resolution suffered no amendments, no exclusions, no demands that it became law.

**The 1st Continental Congress of the United States of America Republic publicly declared 2015 the national "Year of the United States of America Republic".** The document known as **PUBLIC LAW #111-79** was signed and enacted into law on 03/01/2020 by the following **SIGNATORIES to this Legislative Act in Attendance;**

**General Congress Assembled, United States of America Republic**

It reads as follows:

**PUBLIC LAW 111- 79, on 03/01/2020**

**JOINT RESOLUTION**

## **Authorizing and requesting the President**

**to proclaim and** establish provisions in accordance with the **Constitution** and **Laws** of the **United States of America Republic**.

**WHEREAS**, the United States of America Republic, being a Perpetual Government is an autonomous National Republic form of Government lawfully incorporated and chartered for the benefit and protection of “We The Moorish American People”, by its Declaration of Independence, Free National Constitution and By-Laws, and aforementioned Articles;

**WHEREAS** the United States of America Republic’s official language is the English language;

**WHEREAS** the Moorish American People have made a unique contribution in shaping the United States of America Republic as a distinctive and blessed nation of people and citizens;

**WHEREAS** the Moorish American People are a People of deeply-held religious convictions springing from the Holy Scriptures of the Holy Koran of the Moorish Science Temple of America and the Learning, Teachings and Truth of the Holy Prophet Noble Drew Ali. The Holy Prophet Noble Drew Ali led his People back to the Principles and standards of their ancient forefathers’ Free National Principles and Standards;

**WHEREAS** the Principles of Love, Truth, Peace, Freedom and Justice inspired concepts of civil government that are contained in our Declaration of Independence and Constitution of the United States of America Republic;

**WHEREAS the Moorish American People**, are now in great comprehension that, as a Nation of People being Nationwide in scope to achieve peace as well as unity as a single harmonious Nation, there must be uniform Laws for the Nation. The **Constitution** and **Laws** of the **United States of America Republic** are *"the Rock on which our Republic rests"*;

**WHEREAS** the history of our Nation clearly illustrates the value of a Nation to be able to create and pass its own Laws are beneficial to a Society to Enforce the Laws of the Nation. This is not to remove or change **The Moorish American People** from voluntarily applying and extending the learning, teachings and truth of the Holy Koran of the Moorish Science Temple of America in the lives of individuals, families, or in their society as a nation of People;

**WHEREAS** this Nation now faces great challenges that will test this Nation as it has never been tested before; and

**WHEREAS** that renewing our knowledge of Law, Divine and National and

having faith in Our Universal Creator through Holy Scriptures of the Holy Koran of the Moorish Science Temple of America, the Holy Bible and the Great Qu'ran of Mohammed as we honor all the divine Prophets Jesus, Mohammed, Buddha and Confucius. Therefore, the **Constitution and Laws of the United States of America Republic** and knowledge of the aforementioned Holy Scriptures can only strengthen our nation. I, President Christopher H- Cannon: Bey, therefore establish with the consent of the Continental Congress the provisions as the **Laws of the United States of America Republic**:

**NOW, THEREFORE, be it Resolved** by the Continental Congress of the United States of America Republic in Continental Congress assembled, That the President is authorized and requested to designate the administration of said laws.

# **TITLE I – Statute**

## **Public Law 111-79**

### **Chapter 63**

#### **EFFECT OF GOVERNMENT SEAL ON DOCUMENT**

##### **BODY OF LAW**

###### **- Effect of Government seal on document**

**(a) With respect to any contract, conveyance, or similar document executed by or on behalf of a domestic or foreign corporation, the presence of the Government seal, or a facsimile thereof, attested by the secretary State of the Government, or other officer to whom the bylaws or the directors have delegated the responsibility for authenticating records of the Government, shall attest:**

**(1) That the Government seal or facsimile thereof affixed to the document is in fact the seal of the Government or a true facsimile thereof, as the case may be;**

**(2) That any officer of the Government executing the document does in fact occupy the official position indicated, that one in such position is duly authorized to execute such document on behalf of the Government, and that the signature of such officer subscribed thereto is genuine; and**

**(3) That the execution of the document on behalf of the Government has been duly authorized.**

**(b) When the seal of a Government or the facsimile thereof is affixed to any document and is attested by the Secretary State of a Government, or other officer to whom the bylaws or the directors have delegated the responsibility for authenticating records of the corporation, a third party without knowledge or reason to know to the contrary may rely on such document as being what it purports to be.**

**(c) The seal of the Government may be affixed to any document executed by**

**the corporation, but the absence of the seal shall not itself impair the validity of the document or of any action taken in pursuance thereof or in reliance thereon.**
